

Privacy Policy

This Privacy Policy is for the Lori DiVito PhD - hereafter also called the 'web site' - which is a personal web site that aims to inform and share content. There is no commercial intention to the web site. This Privacy Policy is to help you understand our practices with respect to the collection, use, and disclosure of information we collect from you by visiting the web site.

1. What information we collect; how we collect and use the information

We receive, collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; e-mail address; computer and connection information. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email address).

When you join our mailing list or fill in the contact form, we collect personal information you give us such as your name, phone number and email address. Your personal information will be used to send occasional information about new content, events or activities organized by Lori DiVito or by the Collaborative Innovation & Entrepreneurship research group. We do not conduct transactions on the web site.

2. How we store and disclose personal information

The Lori DiVito PhD web site is hosted on the Wix.com platform. Wix.com provides the online platform that allows us to display and share our research with you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

3. Cookie Policy

We use cookies based on the Wix.com platform for reasons such as:

- To provide a great experience for your visitors.
- To monitor and analyze the performance, operation and effectiveness of Wix's platform.
- To ensure the platform is secure and safe to use.

In general, the cookies are categorized as essential cookies. However, considering that the Wix.com platform provides additional multiple components, codes, third-

party applications, the web site may include other types of cookies which might require specific settings.
